2 The following is a transcript of a telephone
3 conversation between D'ANGELO LEE and BRIAN POTASHNIK,
4 UNIDENTIFIABLE (UI)
5 (Phone ringing)
6 BRIAN POTASHNIK (POTASHNIK): Hello.
7 D'ANGELO LEE (LEE): Yeah, BRIAN, sorry about that.
8 POTASHNIK: Yeah, her check's, her check's ready, she
9 just has to come pick it up. I just asked CHERYL.
10 LEE: Okay cool. Yeah her, her file is pretty
11 extensive. I mean, I, I...
12 POTASHNIK: Okay.
13 LEE:...get a copy of it every, every month and so...
14 POTASHNIK: No, I just wanta make sure for, you know,
15 for our files, and for hers, that we've got...
16 LEE: Yeah, she, she...
17 POTASHNIK:...all that covered.
18 LEE: As a matter of fact, I have another meeting with
19 KUNKLE, in, ah, 2 weeks, at the end, I think it's the
20 24th of this month, or the latter part of this month.
21 POTASHNIK: Well, we got a call from, you know Dallas
22 Central Ministries?
23 LEE: Dallas, yeah. I'm familiar with them.
24 POTASHNIK: Well, they called us up, and said, yeah,
25 we got an inside track on the SUMMER BREEZE, and we've

1 got the support of the mayor, and CHANEY, all this
2 stuff. I mean, that's the deal that we've been
3 chasing. I don't know if I wanta do the deal with
4 them.

5 LEE: No, that's...

6 POTASHNIK: We don't need them. Huh?

7 LEE: No, no. Not at all, particularly not with
8 CHANEY, 'cause he's gonna be gone in a minute. So we
9 already got it, it's probably in the, ah, in the,
10 ah...

11 POTASHNIK: Well, that's nice. That's why I was
12 surprised to get that call, because I'm like, no,
13 we're not interested. But I'm thinking, shit, we
14 can't let that deal go.

15 LEE: No, those guys, as a matter of fact, I know the
16 new director over at, ah, at the ministry, and I
17 remember he mentioned it to me, that he would like
18 that property.

19 POTASHNIK: Yeah, they're working (UI), but...

20 LEE: Yeah, I told him you couldn't; I didn't tell him
21 what we were doing, he just mentioned it to me. I
22 said, well, go ahead and do what you gotta do, but I
23 already know, we got it on lock down.

24 POTASHNIK: Alright, well my phone's gonna go off, but
25 SHEILA's fine. She just, you know, needs to come by

1 and pick up her check, but...

2 LEE: Hey, BRIAN, when are you gonna be back, 'cause I
3 wanta show you, ah...

4 POTASHNIK: I'll be back on Tuesday. I told, I told
5 her, I'd meet with her on Tuesday.

6 LEE: Okay, but I wanta meet with you too. I wanta go
7 and, ah, I'm, I'm still have this, ah, this, ah,
8 concrete place I wanta look at, and I wanta look at
9 FERGUSON, and I got another, ah, deal that, I wanta
10 discuss with you.

11 POTASHNIK: Alright, well let's, let's do it next
12 week. I'll be, I'll be back in on Tuesday.

13 LEE: Okay, put me on your schedule, man, if not
14 Tuesday, ah, ah, that evening or whatever, you know,
15 after 6 or something, we can...

16 POTASHNIK: Okay.

17 LEE:...get a bite to eat.

18 POTASHNIK: Alright.

19 LEE: Alright man, have a safe trip.

20 POTASHNIK: Okay, alright thanks, bye.
