

1 REAGAN: Hey, JIBREEL.
2 RASHAD: Hey, what's going on big brother?
3 LAUGHING
4 REAGAN: Hey, what's going on?
5 RASHAD: UI
6 REAGAN: Yeah, I was just leaving you a message, man.
7 RASHAD: You were just leaving me a message?
8 REAGAN: Yeah, yeah, UI.
9 RASHAD: I got ahh, I got RICK, uh, on the, on the, in,
10 you know, a conference call, 'cause he just got through
11 talking to BILL, and I kept it real simple. He tried to
12 ahh, he tried to get the information right there...he got
13 a fax and he spoke to you UI I said first and foremost
14 uh, we're gonna need Mr. Reagan out of the equation.
15 This has nothing to do with Mr. Reagan, this has
16 something to do with RA-MILL construction based on
17 what we discussed for the last six months in principle.
18 I said, whether or not you made a deal, that's up to you.
19 All we did was fax you an invoice. And I was just
20 giving it, giving it to him like that. And I, and I
21 said, and from my understanding, that you said you was
22 confused. So let me just spell it out for you. Ahh,
23 it seemed like you just UI a terrible question. You made
24 an answer to your own question. So, at this time, you
25 know, I told him, at this time, we not going to you know,

1 entertain, you know, this, this back and forth this ping
2 pong mentality. You got our invoice, you know we
3 spoke about it in principle, the ball's in your court. So
4 you make the call, and we'll talk to you in the morning.

5 REAGAN: Yeah, well that, well, I told him, I said I
6 wasn't privy to any of those discussions...

7 UNIDENTIFIED MALE (UM): Mm-hmmm.

8 REAGAN: ...and ahh, you know, that, that's a matter
9 that he need to take up with you all. Ahem, out of
10 courtesy, they sent me a copy of the invoice, and ahh,
11 you know, the, as it relates to our relationship on
12 the, ahh, this project, as project managers, I say,
13 other than that, you know, I, I can't comment any
14 further. So that's something y'all need to work out.

15 LAUGH And that's, so, so that's, that's where,
16 that's where that is. And ahh, I made sure that his,
17 I made sure that, ahh, the right people saw a copy of
18 the invoice. Which I'm sure has, ahh, you know,
19 pretty much put the pressure on him to deal with it.

20 UM: Mm-hmmm.

21 Yeah, so, you know, I, I, I can't, you know, other,
22 other than, other than flushing him back to y'all, and
23 ahh, you know, y'all working, working out the details.

24 UM: Mm-hmmm.

25 REAGAN: You know that, that's, that's really where

1 that need to work. That, that's really how that
2 need to work. So, so, I, I put it, put your invoice
3 in front of the right people. So that, ahh, he have
4 to answer up to that.

5 RASHAD: Okay.

6 REAGAN: So, y'all got, y'all got the right leverage
7 on it.

8 RASHAD: Okay. We definitely appreciate it...
9 and I know, just by conversating with him tonight, he
10 definitely ahh, ahh, definitely ahh, ahh he, he's
11 definitely uneasy, so to speak.

12 REAGAN: Yeah, yeah, yeah.

13 RASHAD: So you, you keep the pressure on him UI
14 the ball is back in our court, and we just got through
15 talking to him for about 30 minutes, and, and I wasn't
16 gonna drag the conversation out this evening, and I just
17 basically told him, you know, you know, we're tryin' to
18 work. And ahh, that's what it is right now.

19 REAGAN: Yeah, I told him, I said, well, you, I told
20 him that he, you know, ahh, ahh was, was a, a part of
21 the meeting, and whatever overtures he made or
22 commitments he made, you know, that's for him to, ahh,
23 sort out with you all. Yeah, so, you got, you know,
24 just, y'all just work it like y'all need to work it,
25 brother.

1 LAUGHTER

2 REAGAN: And work, work what y'all need to work out
3 of it. Ahh...

4 RASHAD: We gonna' meet with him early in the morning,
5 so, you know, I know his thing's coming up later in
6 the afternoon, I guess, so we gonna try to...

7 ROBERTSON: It's gonna be delayed right?

8 REAGAN: Huh? Oh yeah, yeah, yeah that, that's off.
9 That's off.

10 ROBERTSON: When it going, when, when is it going to,
11 ahh, come back up?

12 REAGAN: Ahem, I don't, you know, ahh, they can, he
13 pulled it for, you know, they can pull it for two
14 weeks at a time. And ahh, you know, I, I don't know,
15 like I told BILL, I don't know what the fate of that
16 thing is at this point. ...LAUGHING... Yeah, so, I, but
17 I told him he definitely need to work out, work
18 something out with you all.

19 UM: Mm-hmmmm.

20 REAGAN: Yeah.

21 ROBERTSON: 'Cause he, he making it like, well, you know,
22 he's gonna put some, some kind of a twist in it. He's
23 saying it like this, he don't, if his deal don't come
24 up tomorrow, then he gonna lose his contract, da-da-
25 da-da. I'm like, well,...

1 REAGAN: He gonna do what?

2 ROBERTSON: Lose some kind of contract on the deal, he
3 gonna, he...

4 REAGAN: Well, he, well, yeah, well, you know...

5 ROBERTSON: ...gonna get an extension.

6 REAGAN: ...that, that's, that's, that's, that's his
7 thing. You know that's, all contracts, you always
8 have the option to extend your contract.

9 ROBERTSON: Exactly.

10 RASHAD: I was about to say that, yeah.

11 REAGAN: You know ...STUTTERING... I ain't, I ain't
12 concerned about that.

13 UM: Mm-hmmm.

14 REAGAN: Not at all, you know? I know how those
15 deals work.

16 UM: Hmmm.

17 REAGAN: He told me, he told me, that he, he have 'til
18 the end of the month, before his contract is up, and, and
19 I said, well, you know, that's, sometimes it be like
20 that. ...LAUGHING...

21 You know.

22 RASHAD: That's right. Well, you know, what, what,
23 what a good thing about it is that now we got some
24 leverage, and ahh, I said we gonna meet with him early
25 in the morning, and, and just let him know...

1 REAGAN: Y'all gonna meet, y'all gonna meet with,
2 ahh, BILL?
3 ROBERTSON: He's gonna call us in the morning..
4 RASHAD: Yeah, he's gonna call us.
5 UM: UI.
6 REAGAN: Yeah, okay. Okay, where, where is ahh, I
7 talked to D'ANGELO a little earlier, before I went
8 into the basketball game. And so, are y'all supposed
9 to be meeting tomorrow as well?
10 ROBERTSON: With D'ANGELO?
11 REAGAN: Yeah.
12 ROBERTSON: Well, we 'sposed, I supposed to have met
13 with him today. We probably meet at some point tomorrow.
14 REAGAN: Huh?
15 ROBERTSON: I said, we may meet with him tomorrow at
16 some point.
17 REAGAN: Okay.
18 UM: UI.
19 REAGAN: Y'all, y'all, y'all be sure and get
20 together.
21 UM: Okay, okay.
22 REAGAN: Alright, then, so you don't, so you, y'all
23 don't be sending no mixed signals.
24 UM: Right, right.
25 REAGAN: 'Cause, 'cause, 'cause ahh, BILL, BILL is

1 definitely gonna, gonna talk back with him.

2 RASHAD: Mm-hmmm. Mm-hmmm.

3 REAGAN: So, so, y'all, y'all three be together, ahh,
4 before y'all have a, any kind of discussion with, with
5 BILL.

6 ROBERTSON: Mm-hmmm.

7 REAGAN: Yeah, that, that's my strong recommendation
8 to you guys. Y'all, y'all get with D'ANGELO and
9 y'all, y'all, ahh, talk and work, work through a strategy

10 ROBERTSON: Okay.

11 REAGAN: be, before y'all go on to a discussion with BILL.

12 ROBERTSON: Okay.

13 REAGAN: Alright.

14 RASHAD: Okay.

15 REAGAN: Alright, little brother, y'all take care now.

16 RASHAD: Alright.
