2 HILL: Hello?

12 BILL and them hadn't made any progress, so we just

13 need to pull that one off the table, man.

14 HILL: Yeah. Yeah. I think, I think I may end

15 up seeing, ah, I think I'll end up seeing SUZAN on, I

16 think tomorrow, so I'll kinda get that message over to

17 her. I got you. UI I mean, its gotta move, something's

18 gotta happen, but no, I'm, I'm with you, I'm with you.

19 REAGAN: Okay, now I, I just wanted to have you,

20 ah, just encourage D'ANGELO, ah, to just, just,

21 you know, put some space between him and BILL.

22 HILL: Okay, okay, okay.

23 REAGAN: Because, you know, I know, I know

24 D'ANGELO is sometimes tempted to talk with BILL.

25 HILL: Yeah, yeah, go in there and talk to him,

1 yeah, yeah, yeah.

2 REAGAN: BILL, BILL ain't to be trusted.

3 HILL: That's right.

4 REAGAN: I told him, I said, man, he, he will record  
5 your every conversation.

6 HILL: That's exactly right. That's exactly right.

7 REAGAN: And you don't, you don't want to put  
8 yourself in that position.

9 HILL: That's right. That's right.

10 REAGAN: Compromised and, and, and you  
11 know, now is certainly not the time with all this  
12 other stuff, the politics...

13 HILL: That's exactly right.

14 REAGAN: You know the politics out here.

15 HILL: That's exactly right.

16 REAGAN: So, ah...

17 HILL: I'll remind him about that, we'll talk about  
18 it some today, I will. Let's get it going.

19 REAGAN: I, I mean, I'm, I'm, I'm gonna hold,  
20 I'm gonna hold BILL's feet to the fire. We have ah,  
21 we have a ah, ah, ah, project management  
22 relationship. BILL and them not gonna come in  
23 here and not gonna utilize black contractors.

24 HILL: That's right, that's right.

25 REAGAN: UI... and, and, and ...

1 HILL: And that was a commitment that they made...

2 REAGAN: That was a commitment they made, and,  
3 and since he can't get me to move on it, he is  
4 slippin, yeah, well, not slippin, he calls D'ANGELO,  
5 and D'ANGELO, you know, I'm afraid has had  
6 conversation with him

7 HILL: Yeah.

8 REAGAN: But, you know, you don't need to

9 HILL: Yeah.

10 REAGAN: you don't need to have those

11 HILL: Yeah, yeah.

12 REAGAN: Especially with BILL, man.

13 HILL: Yeah, yeah. STUTTERING that's absolutely  
14 right, man.

15 REAGAN: Okay

16 HILL: In fact, I'll call on that right now, but I got it,  
17 UI stay in touch, man.

18 REAGAN: Okay, okay, brother, we'll see you,  
19 AL and I be down there, uh, either on Wednesday.  
20 Are we having any more debate on that, on that,  
21 uh, Mayor's deal?

22 HILL: Oh, yeah, we goin' over, we, we, we gonna  
23 have some up at THURGOOD MARSHALL tonight,  
24 and then we'll have some on March the 2nd down  
25 at the FAIRMONT, so that's the next two things that

1 we'll do, yeah, man, yeah, yeah.

2 REAGAN: Okay, brother.

3 HILL: And then, wait a minute, the other thing is we  
4 gonna meet tomorrow...

5 REAGAN: Okay.

6 HILL: At 11 o'clock

7 REAGAN: Okay.

8 HILL: Up at FRIENDSHIP WEST. Kind of an  
9 umbrella group.

10 REAGAN: Okay, FRIENDSHIP WEST at 11 o'clock.

11 HILL: FRIENDSHIP, 11 o'clock.

12 REAGAN: Oh, okay, UI.

13 HILL: If you can, show up. man.

14 REAGAN: Well, we'll, we'll, we'll be there, man.

15 HILL: Okay.

16 REAGAN: STUTTERING I just wanted to convey that to  
17 you, DON, and you know, just, just, jut pull it, man, and  
18 we'll, you know, we'll just deal with it day by day.

19 HILL: UI Day by day. I look to hear from you, man.

20 REAGAN: Alright, brother.

21 HILL: Thanks, man.

22 REAGAN: Thank you so much.

23 HILL: Appreciate it, man, alright.
