22 the, the, the... I'm going to attempt to anyway,
23 reshape the social service programs that they
24 currently have in place. I've already set that up.
25 Uhm, and she is like, hallelujah.

1 HILL: They need, they need, they need to stay with it.

2 FARRINGTON: Hallelujah.

3 HILL: Don't run. You know, don't run from it, let's
4 do, deal with it.

5 FARRINGTON: Yeah, yeah. But, but it's going to
6 happen better because I'm going to stick with it. And
7 I'm going...

8 HILL: (Ul)

9 FARRINGTON: ...to go in there.

10 HILL: Yeah.

11 FARRINGTON: And just really, you know, evaluate the
12 situation. I have them giving me some demographics
13 on the property. This, you know, and, and they're
14 going to do some things that, that will help me to be
15 able to do what, assess the situation and, and just,
16 you know, I just have a natural knack for those
17 things, for social service issues. And that's
18 something when you have a natural knack for, that's
19 just something that God wants you to do, that He put
20 in you so ah, we're going to see what, what He's about
21 to do.

22 HILL: And, and I will say...

23 FARRINGTON: But I strongly sense that He is about to
24 do something and, and it's going to shine big time.

25 HILL: Good, good.

1 FARRINGTON: Meanwhile, I've already moved forward on
2 that other situation I was telling you about last
3 night. I'm going to put... I'm going to get in
4 communication with the mayor of, of a, a, Baton Rouge.
5 And I'm going to...

6 HILL: You go, you going for it, huh.

7 FARRINGTON: See what he has to say about the ah,
8 what kind of land. What's the, what's the need for
9 affordable housing there, all of it. And at the same
10 time, cure this situation, and take
11 BRIAN there. And that, since I'm the consultant on it,
12 I'm going to make something off of that too.

13 HILL: Nothing wrong with that. That's a winner.
14 Sounds like y'all had a discussion this morning.

15 FARRINGTON: Oh, it was deep. It was heavy. They
16 were like, hallelujah. That woman was like, praise
17 the Lord.

18 HILL: They need to listen. They don't want to
19 listen.

20 FARRINGTON: They don't listen to her either.

21 HILL: And don't forget about the resources, less
22 expenses, that you got with JAMES ALLEN. Don't forget
23 about that resource now.

24 FARRINGTON: Well, that's exactly what I was about to
25 ask you later on. But I couldn't do it while I was

1 driving.

2 HILL: Okay.

3 FARRINGTON: And that is, get his number. And I'm
4 going to talk with him like immediately. And see if
5 he can do the same thing for ah, for around the kind
6 of money that they, that they have budgeted to spend.

7 HILL: Yeah, yeah.

8 FARRINGTON: And see if we can do it that way. If,

10 HILL: Well, he tried.


11 FARRINGTON: And I, I, I ain't going to play with

19 he's got a lot of experience.


20 FARRINGTON: Well, I'll explore both options and

15 HILL: I'm gonna call you back in two minutes, okay. I,
16 I, lost a hundred dollars so I'm trying to find it.
17 So, I'll call you right back, okay?

18 FARRINGTON: And whoever calls, or comes in and...
19 Oh, well. Okay.

20 HILL: I just want to check on. I just want to check
21 on. I'll call you right back.

22 FARRINGTON: All right.

23 HILL: All right, thanks, honey.
