

1 REAGAN: Hello, brother.

2 LEE: Hey, man, how you doing, sir?

3 REAGAN: I'm doing good, what about yourself?

4 LEE: Good, good. I, I got your message in, in regards
5 To that invoice.

6 REAGAN: Do what now?

7 LEE: I got your message in, in regards to that
8 invoice.

9 REAGAN: Uhm, no, it was, it's already done, man.
10 That's an old message.

11 LEE: Okay, okay.

12 REAGAN: Yeah, that was an old message.

13 LEE: You got the check already?

14 REAGAN: Do what now?

15 LEE: You got the check already?

16 REAGAN: Oh no, I haven't gotten the check, but the
17 message, the message that I left for you, man, that
18 was, goodness, last week.

19 LEE: You did it for, was it, it 180,000?

20 REAGAN: Huh?

21 LEE: It was for 180,000 right?

22 REAGAN: The other day when we were there, the Super
23 Bowl thing.

24 LEE: Right.

25 REAGAN: She, uh, she did it for 180.

1 LEE: Right. Well, a, a, a, a, few things, man, that,
2 um, I mentioned to those guys, that um, it's just, you
3 know, a little between me and you, I mean, I shared it
4 with DON, so so when I say between me and you, I've
5 already shared with him, and, and, you know, uh, DARREN,
6 it's, I'm in a, I'm in a position that I'm damned if I
7 do and I'm damned if I don't, and you know, and maybe
8 you can just kind of help me how to deal with this, is
9 that, you know, my boys they, they talking bad about me.

10 REAGAN: Who talking bad about ya?

11 LEE: Uh, you know, my boys I'm trying help out, and
12 I've done everything that I could, man, to possibly
13 make this deal work for them. I've literally given
14 them money, and they trying, you know, they got UI
15 goin up to them I'm trying to fuck them out of their deal,
16 and you know, and my thing is that, I mean, I'm gonna
17 be damned if I do and damned if I don't, and I'm not
18 going to pay you to damn me.

19 REAGAN: Yeah.

20 LEE: You know.

21 REAGAN: Yeah, well.

22 LEE: And that, it's, it's, it's bothering me now. I've
23 even called them I said I want to meet with them tomorrow,
24 because I know what's being said, because it's, it's been
25 said to me by several other people, and that, that,

1 that troubles me. I know that I'm doing everything that
2 I can to make this deal work.

3 REAGAN: Well, how do they, how do they figure you trying
4 to fuck them out of the money, man, and you, I mean...

5 LEE: I, I'm not making any money off them. I'm giving
6 them the deal.

7 REAGAN: I mean...

8 LEE: I didn't ask them for none of the 180,000. I
9 didn't ask them for a big tax in, in, in the concrete, I
10 didn't ask them for any of that. But, the issue is that,
11 I'm trying to fuck them out the deal, and, and I called
12 them today. I said listen man, I'm not going to pay folks
13 for me to, to talk, for them to talk about me. I'm just
14 not. So, we need to get together and kind of get some
15 resolution on this, because I'm not putting myself on the
16 line, to help my boys, and my boys are sitting up, you
17 know, you know, talking bad about me.

18 REAGAN: Aww, man, shit. ...LAUGHS...

19 LEE: I mean, I know that's UI

20 REAGAN: I, I, I hear you, I hear you little brother,
21 I hear you.

22 LEE: I'm not going to be damned, and if I'm going to be
23 damned, let me be damned to make the money.

24 REAGAN: Yeah.

25 LEE: But, I'm not going to damned, and give you some

1 money, then you gonna talk bad about me, nah.

2 REAGAN: Now D, is, is ah, is the guys from out of
3 Houston, are they gonna still....

4 LEE: Excuse me?

5 REAGAN: Huh?

6 LEE: I didn't hear you, I'm sorry.

7 REAGAN: The guys out of Houston that were going to
8 get you, the numbers on the concrete, are they still in?

9 LEE: Yeah, I mean, I did the numbers, I mean, my, my,
10 it's my guys that are going to do the deal.

11 REAGAN: Okay.

12 LEE: I mean that the company in Houston that's, that's
13 running the deal is very credible, I mean, you know,
14 as far as bonding, and far as...

15 REAGAN: Yeah.

16 LEE: ...You know, Bill or no one can ever come and,
17 and question their credentials.

18 REAGAN: Okay.

19 LEE: So, I mean, that's why he (talking at same time)
20 he did not want to use RA-MILL.

21 REAGAN: Was RA-MILL and them going to be, I mean,
22 were they going to be in on the deal, ah, with the
23 concrete as well?

24 LEE: Yes.

25 REAGAN: They going to be linked to it?

1 LEE: Yeah, 'cause, 'cause the whole deal is, and, and,
2 and I, uh, I'm very sincere about this, uh, DARREN, is
3 that I don't mind taking my boys, and taking their company,
4 and building capacity.

5 REAGAN: Right, I hear you.

6 LEE: Meaning that I will get you on multi-million
7 dollar deals. I don't mind doing that, and you make us,
8 you know, some money off of, off of the deals, that's
9 great. I, I, I, I'm committed to that, and, and I, that's
10 the situation I'm up against right now, and I'm, and
11 I'm not going to walk away from that.

12 REAGAN: Okay.

13 LEE: It's, STUTTERING really, it's very painful to
14 do it when I know that I'm, I'm doing everything that I can
15 to make this deal work for you, and y'all are just,
16 you know, trying to say I'm trying to screw you out of
17 the deal.

18 REAGAN: Man, well, just, you know, uh
19 hey brother, sit 'em down, and have a, uh, take 'em to the
20 wood shed, that's all, you know, and, and...

21 LEE: ...STUTTERING... I don't know how to politically
22 go to the wood shed.

23 REAGAN: Nah, I mean, you just UI.

24 LEE: When I go to the wood shed, that's the, that's the
25 time to box.

1 REAGAN: Well, I mean, when, if you, you...

2 LEE: If I go to the wood shed, I'm cutting a nigger.

3 REAGAN: Well, that's okay, sometimes a little blood
4 ain't gonna hurt nothing. ...LAUGHS...

5 LEE: My dad taught me UI unless you going to use it.

6 REAGAN: Yeah, well if you, if, if...

7 LEE: Don't pull it to play.

8 REAGAN: Yeah, if, if they, if, if you need to have a
9 come to Jesus meeting with them, man, do that and see
10 if they down for you. If they not down for you, you
11 know.

12 LEE: Well I, I just got a promote, I mean, I got a
13 proposal that Don told me for them, that you know, that
14 you know, that y'all could put some teeth in this deal,
15 and you're not gonna sit back and collect a check.

16 REAGAN: Do what now? I didn't understand you.

17 LEE: I said, ...STUTTERING... I'm going to meet with
18 them tomorrow.

19 REAGAN: Okay.

20 LEE: And discuss some other issues with them, so.

21 REAGAN: Okay, well, ah, had BILL, had BILL called
22 you any?

23 LEE: No.

24 REAGAN: Okay, well, he, ah...

25 LEE: He will. UI he'll call me.

1 REAGAN: Well, he, he, he's, ah, nervous, brother,
2 big time, and I didn't cut him no slack, and ah, you
3 know, we, ah, DON has pulled it for, off the agenda
4 for tomorrow, and ah, that's cool, and so we'll, we'll
5 have, you know, some time to work out the kinks.

6 LEE: Well, when you get the check, call me. Do not
7 call them.

8 REAGAN: Okay, well, they, 'cause they, he's, ah,
9 here's what I, here's, here's, here's what Bill...

10 LEE: The check's gonna be made.....
11 The check's gonna be made payable to you, right?

12 REAGAN: Nah, the invoice says, the invoice says
13 payable to RA-MILL. Now if, if this is what you, if,
14 if what you telling me to do is go in and, and a broker it,
15 if you, if you, if you saying, hey, go in there and
16 broker it, and I want the check, you know.

17 LEE: I want it to you, make the check to you,
18 and if they don't want to put any piece in the deal,
19 they getting, I'm not, they not getting any money.

20 REAGAN: Okay, well, let me, let me, well, I'll ah, I'll
21 I'll run that by, I'll run that by BILL, and ah, you know,
22 I'll let you know, you'll know just how that's going to go.

23 LEE: Okay.

24 REAGAN: Yeah, you, you, I'll talk to him, I'm sure
25 he's going to call me tomorrow, I'm not gonna, I'm not

1 going to rush and call him, he's sweating, so he needs...

2 LEE: I'm sure he'll be trying to call me, but...

3 REAGAN: Yeah.

4 LEE: ...you know, I'm going to refer him back to
5 you.

6 REAGAN: Yeah, tell him to talk to me, and ah, ah,
7 I'll just, you know, I'll give him word on that.

8 LEE: And also I'm doing at the end of the month, um,
9 I kind of want your support in this, I'm doing a um, a
10 masquerade ball fund raiser for COUNCILMAN HILL at the
11 Crescent Club.

12 REAGAN: Okay, well just, just let me know, little brother.

13 LEE: And, so I want to kind of gather some support
14 with that as well so.

15 REAGAN: Okay. Well, just, just let me know, let me
16 know what we need to do.

17 LEE: Alright.

18 REAGAN: And I'll, and I'll keep you up to speed on, on
19 this other thing here.

20 LEE: I don't want the check in their name. I need
21 you to handle that, I don't want the check in their
22 name.

23 REAGAN: Okay.

24 LEE: I want it to go to you and, when I tell you how
25 to cut the check then we'll cut it.

1 REAGAN: Okay, well I'm, I'll, I'll give that to
2 BILL, and, and ah, ah, what, what you need to do then,
3 if BILL call you, and he try to talk to you...
4 LEE: I'll refer him to you.
5 REAGAN: ...when he, when he, no here, here's the thing.
6 When he talk to you, when he talk to you, and he mention
7 anything about RA-MILL, you tell him to call me, that
8 you've given, you've given me your, ah, ah, concern, your,
9 your concerns on that, and just to talk to me. Put it
10 to him like that, say you've given it to DARREN, you
11 give, ah, you told DARREN how you want that handled.
12 LEE: Okay.
13 REAGAN: Alright, brother, I'll take care of it.
14 LEE: Bye, man, I appreciate you, thank you.
