

1 D'ANGELO LEE: Yes sir.

25 tomorrow, I'm just looking at the zoning case

1 schedule. It's gonna be the 10th of August before
2 it hits the Council's desk?

3 LEE: Yeah. And what you need to do is
4 make...

5 LEE: Sure you call MELVIN TRAYLOR

6 SLOVACEK: MELVIN TRAYLOR. Yeah.

7 LEE: And meet with him and explain the deal
8 to him, clearly. And talk to him every day up
9 until it comes to the ahh CPC and meet with
10 him too.

11 SLOVACEK: Okay.

12 LEE: Come to CPC. But call him today. Tell
13 him you wanta meet with him, you got a, a zoning
14 paper UI you wanta explain it to him. You wanta
15 let him know whatever you tell him that LEO'S with
16 him, and get LEO to meet with him. Whatever you
17 need to do, you try to avoid any type of...

18 SLOVACEK: Conflict with anybody.

19 LEE: Right. You need your Commissioner on
20 board with you.

21 SLOVACEK: Okay.

22 LEE: He's the one gonna, gonna rally ahh the
23 rest of the folks, and I'm gonna recuse myself
24 from it.

25 SLOVACEK: Okay.

1 LEE: So you talk to him...

2 SLOVACEK: Are you...

3 LEE: And you need to talk to UI to, to

4 ANGELA WASHINGTON about the LKC.

5 SLOVACEK: Okay.

6 LEE: So I think DON got the number up.

7 SLOVACEK: DON got the number up?

8 LEE: Yeah, but you need to call ANGELA

9 WASHINGTON at, 'cause I've already introduced

10 it to her.

11 SLOVACEK: ANGELA WATSON?

12 LEE: ANGELA WASHINGTON.

13 SLOVACEK: WASHINGTON.

14 LEE: She is the Commissioner for MAXINE.

15 SLOVACEK: Okay.

16 LEE: You need to call her and let her know

17 what zoning is coming down the pipeline.

18 SLOVACEK: Okay. UI for the LKC, right?

19 LEE: Yeah, for the LKC and call MELVIN for

20 the SOUTHERLAND piece.

21 SLOVACEK: Gotcha.

22 LEE: Now, I could talk to MELVIN. I just

23 have to recuse myself from the vote.

24 SLOVACEK: Now, if you recuse yourself on

25 the vote,...

1 LEE: We'll get it done.

2 SLOVACEK: And there's, but no, but there's
3 city dollars in there. Isn't that, isn't that,
4 isn't that ahh possibly...

5 LEE: No.

6 SLOVACEK: Shedding some light there that
7 might, they want, might want further investigation?

8 LEE: No.

9 SLOVACEK: Because again, you're not involved
10 in there, you're not on any paperwork. You're,
11 you're not on there anyway.

12 LEE: Well just to cover our butt, I mean...

13 SLOVACEK: Okay.

14 LEE: If they, if they checked it, it'll
15 come out.

16 SLOVACEK: Right. Okay.

17 LEE: But if I voted on it, then that, that,
18 that gives 'em something.

19 SLOVACEK: Right. Okay.

20 LEE: Alright.

21 SLOVACEK: That's what I wanta know man. So,
22 we're not gonna hear anything till about
23 Thursday, huh?

24 LEE: Yeah. We gonna get it.

25 SLOVACEK: Okay.

5 care of you, and...
6 SLOVACEK: Yeah.
