In regards to the tools or the instructions, rest assured my beloved brother that I had mentioned them in order to get to know about your ability to move and go to a certain area to acquire something we would have left you, as a type of exercise on using dead points in our communication, and Allah willing you will realize the importance of these exercises when the time of your meeting with the beloved Shaykh draws near

My beloved brother, don't worry about anything and rest assured that I will always be at your side, but what I ask from you is to show to the brother your individual ability and your aptitude to carry out this work. Allah whom there is no God but Him is my witness

O' Aba-al-Ayyubi when I say that I long for the coming of the day when we will be together with the lion of jihad and the mujahidin because there is nothing better than the rest of the mujahid along with his brothers after fighting in a plain or a valley, so be patient and persevere O' Aba-al-Ayyubi and we will have a meeting Allah willing
