Thank Allah and and [sic] Allah is the greatest

There is no god but Allah Muhammad is Allah's Messenger

("Then Allah sent down His tranquility upon His Apostle and upon the believers, and sent down hosts which you did not see, and chastised those who disbelieved, and that is the reward of the unbelievers.")

Blessed holiday for you also my brother in this good moment I convey to you unpleasant news and but

I hope [UI] it will be from His praise good for us

My dear brother I am [UI] sorry for this

And but on Friday on the same date that you sent me the message on the night of Thursday in the beginning of Friday the blessed Friday // the hour // I was returning to the home on my way from the shopping for needs after the work stopping me occurred and my arrest took place and already the seizure of my car was done for the charge of the driving without a license and already the policeman that stopped me was of those who hate the Arabs so when the investigation with me was completed and already he learned that I am of Arabic

nationality the seizure of my car and my transportation to the prison took place with harsh treatment and with total filth Allah's curse on them so in this blessed date and in the honorable month and Allah knows best

Already I felt that something will happen because this date used to appear to me in the clock at the house when I wake up I look at the clock and find it 9:11

Or in the car 9:11

Only by coincidence I look or I would be leaving for work the same thing already I would have been smiling when I see it because it happens in a random fashion I swear and as though it is a reminder from Allah be He exalted and it increases in me nothing but power and steadfastness and endorsement for what I am in and also my arrest was done on the same date already I remembered that it was the day in which the blessed attack took place and I am in the prison because it occurred in middle of the night at the start of Friday

And but already [sic] strong and steadfast thank Allah I also know that Allah will facilitate my affair for me until the morning I vowed fasting in the prison and already taking me to the hearing took place in the morning and my hearing was done with the discharge with a bond until the American business owner who I work for him came and paid the bond at exactly 4 o'clock the announcement was made that my release will take place and but at the fifth hour already they returned me to the prison once again the taking of my pictures and the photographing of my fingerprints took place I believe that office of the FBI already contacted the prison to confirm my identity after payment of the bond because they wanted to know who paid my bond and at the seventh hour my discharge was done after the verifying that there is not regarding me any kind of suspicions or problems.....already the business owner came and took me at time of dusk to my place at same moment of the fast-breaking approximately the 8 o'clock I relied on Allah and broke my fast already then I knew that there is a meaning and Allah knows best about what happened and that all of it is not a coincidence so what is your opinion my beloved brother I am sorry for this news and but now I suspect that it is I do not want to lie to you and tell you That my home address and my telephone number are not being suspected in the police office now I ask you to inform brother Hussein not to call at my number that he has obtained it now until I get another new number I will give it to you so that you hand it to him only for the caution and I do not know what the rules of the plan do you want me to continue forward towards the coming appointment and I indeed feel that there is a kind of danger because I became somewhat discovered or suspected only because I am an Arab and already I was like a ghost moving in all the states and my imprisonment took place in Texas and my discharge now what is your opinion????

As for me the beloved brother I am prepared to strike them and I did not increase except power and steadfastness and but the basis of the operation was the safety of the beloved brother Hussein before my safety and I will never be happy if the operation was done with success and after it some kind of harm happened to one of my brothers such as the brother Hussein or to me also so we want to remain on the path together with safety until the destruction of the cunning enemy until Allah destines for us from His own He is the Seeing and the Decider

And at the present time I no more own my private vehicle anymore because already its seizure took place and but the business owner already promised me that he will bring it to me and he will take responsibility for it

I indeed deliver to you the picture and you are the counselor and the commander

I am indeed very regretful for this is a type of shortcoming on my part and not from your part and but I swear by Allah that I indeed seek forgiveness from Allah Almighty if it was good or evil or wrath

I convey to you the picture O the dear one so advise me and write to me your instructions I know now that the equipment is ready I indeed O my brother by Allah am not satisfied with what happened because I was ready and but perhaps Allah wants to delay the appointment somewhat perhaps that there was some mistake and I know now what it is my beloved brother I have to change the place of my residence because I am in an exposed location the lost group knows it I believe that it is necessary for me the obtaining of a secure place away [UI] from the views and I indeed know where this place is [UI] from the area which I reside I can put it under my name and so that the brother Hussein can also settle for a period of time in this place so he is not in danger from the security blocks and the searches and I also can keep my residence at the same time so that I distance the eyes in case the place's surveillance happened so [UI] will be normal my place that I live in so it will be another secure den for the brother Hussein and his [UI] away from the suspicions and my situation will be normal I will not have any kind of the companions because I am afraid now after my detention took place they know where I reside at in case a type of doubt happened I do not want that the search takes place and the finding of the brother Hussein with me in the place for example and they begin in the investigations but they will not find anything and but I do not possess the sufficient money to perform that after my situation now

Or my dear brother I have obtained another conviction that is I leave the place of my work and tell them that I am traveling to another state to visit my brother or something like this and I perform the departure and finding a suitable place with the brother Hussein for hiding or I can rely on Allah if it was suitable..... I depart with the brother Hussein and work with him behind the back of the enemy if he was able to manage my affair for finding me some job or something else for the duration of the period that I will remain in the United States

After my performing the operation
So I truly trusted in Allah in this the jihad
And from you the opinion [UI] and from us the execution
Peace on you

As for the garage in the decided building yes rely on Allah there will not be a problem at all as it is my responsibility after I enter the site there are places very close to the site where I can park in them and but I must move fast fast after parking the car because it is a private not public place it is possible that there is some kind of the protection for monitoring the vehicles that do not have a license to park that is why I can pass this gap in the quick timing and the movement from the site before anyone feels and Allah willing I did not and will never allow except in the success over them and from Allah the success

There is no power and no strength [UI] save in Allah Lord of the great throne
