





Collateral Forfeiture Schedule for
 Conduct on Bureau of Engraving and Printing (B.E.P.) Property, Fort Worth, Texas
 Title 31, Part 605.1, Code of Federal Regulations

GENERAL INSTRUCTIONS

- 1) Those offenses designated "MAN" in the collateral forfeiture schedule require a mandatory appearance.
- 2) All offenses arising from an accident causing personal injury or death require a mandatory appearance.
- 3) Any other offense with a dollar amount listed may be paid by a collateral forfeiture.
- 4) All felony cases must be submitted to the U.S. Attorney's Office.

605.1(b)(8)	Unauthorized entrance onto the property without official permission.	\$50

605.1(e)	Unlawfully failed to comply with instructions of (B.E.P. Special Police/Other Authorized Officials/Posted Signs or Notices)	\$50
605.1(f)	Unlawful (use of loud, abusive or profane language/unwarranted loitering/unauthorized assembly/creation of a hazard/improper disposal of rubbish/spitting/prurient prying/commission of an obscene or indecent act) Or other prohibited disorderly conduct.	\$50
	Unlawful (throwing of articles/climbing) upon B.E.P. property.	\$50
605.1(g)	Unlawful participation in games for money or other property/operation of gambling devices/conduct of lottery or pool/sale or purchase of numbers) or any other gambling in or on B.E.P. property.	\$50
605.1(h)	Unlawful entrance or presence on B.E.P. property while under the influence of alcohol or drugs.	\$50

605.1(j)	Taking of photographs on the B.E.P. property without the written permission of the Director.	\$25
605.1(k)	Unlawfully bring a dog or other animal on B.E.P. property without authorization.	\$25
605.1(l)(1)	Failure to drive in a careful and safe manner on the property.	MAN
605.1(l)(1)	Failure to comply with the signals or directions of B.E.P. special police/posted sign.	\$50
605.1(l)(2)	Unlawful blocking of (entrances/driveways/walks/loading platforms/fire hydrants/standpipes) in or on B.E.P. property.	\$20
605.1(l)(3)	Unlawful parking (without authority/in unauthorized location/ continuously in excess of 8 hours without permission/in location reserved for others/contrary to direction of B.E.P. special police/against direction of posted signs.	\$20
605.1(m)	Unlawful carrying of (firearm/weapon/explosives) in or on B.E.P. property.	MAN
