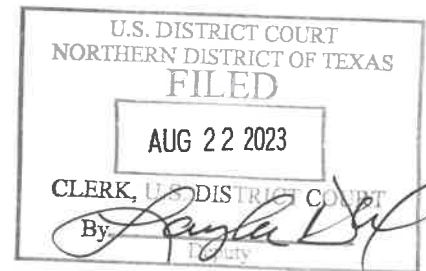


MISCELLANEOUS ORDER NO. 4-13

Court reporters for the Northern District of Texas are authorized to charge the maximum rates for transcripts approved by the Judicial Conference of the United States on the effective dates shown in the attachment to this order. The new rates for Fiscal Year 2024 apply to any transcript ordered on or after October 1, 2023, and the new rates for Fiscal Year 2025 apply to any transcript ordered on or after October 1, 2024.
